### Financial Overview

- 1. Dawn Barbour reviewed the financials. Willis surpassed our Walk-A-Thon goal of \$55,000 which leaves the PTO in an excellent place. It is with great excitement that we will be able to enhance certain things at our school with such amazing fundraising efforts.
- 2. Willis has some new Business Partners. New Gold Business Partners are Spice & Tea Exchange, along with Beyond Dancing. A new Platinum Business Partner is D1 Training Center.

### Walk-A-Thon

- Deb Hossenlopp shared information about current and future PTO purchases.
   Manatee County's Director of Technology will be ordering 12 "whiteboards" to begin our technology enhancement project. It is expected to take about 4-6 weeks for the delivery.
- 2. Mrs. Price also shared that in her meeting with the Director of Technology, she expressed her concerns over our lack of working laptops. He has generously agreed to swap out 176 laptops with new Chrome Books and ALSO provide us with extras, for a total of 240 for our students. We will start with fifth grade and eventually continue with fourth and third graders, so that our school will

- have a 1:1 ratio in those upper grades. After the Spring Fundraiser, the PTO will consider purchasing 50 more laptops.
- 3. The PTO is also researching ways to enhance the playgrounds. The gaga pit for the 1st-5th grade playground has arrived, been installed, and the students are loving it. Mrs. Price shared a petition from one classroom stating that they want to have a tire swing. PTO will research the cost of adding a tire swing to one ore both of our playgrounds.
- 4. Also using WAT money, we have purchased more math manipulatives, Cranium Core/SSYR for the Media Center, and continued staff development. In the future, PTO plans to show videos of exactly how our money is being used and the students in action!
- 5. WAT dates for prizes have all been finalized and letters have gone home with students.

- 1. Amy Hammon Chair of the Spring Fundraiser Event. Amy is very excited for this event and planning is underway. Prospective dates include February 15<sup>th</sup> at The Grove or March 7<sup>th</sup> at the Founders Club. More research is being done to choose a date.
